POLICY:

Regular and Associate One (1) Members that have relocated to British Columbia or the Yukon Territory from a different Canadian Province are eligible to apply for a comparable level of Certification.

Certification Applications are to be made as per Policy 1.3.

ACBOA

Canadian Certified Building Official – Residential: Regular and Associate One (1) members who have received the Canadian Certified Building Official Residential Certification will be eligible to receive **BOABC** Level One (1) Certification.

Canadian Certified Building Official – Part 9: Regular and Associate One (1) members who have received the Canadian Certified Building Official Certification will be eligible to receive **BOABC Level Two (2) Certification.**

Canadian Certified Building Official – Part 3: Regular and Associate One (1) members who have received the Canadian Certified Building Official Certification will be eligible to receive **BOABC Level Three (3) Certification.**

Canadian Registered Building Official: Regular and Associate One (1) members who have received the Canadian Registered Building Official Certification will be eligible to receive **BOABC Level Three (3) Certification.**

TITLE: CERTIFICATION INTERPROVINCIAL ENTITLEMENT

OBOA Ontario Building Officials Association

CBCO Housing: Regular and Associate One (1) members who have received the OBOA CBCO Housing Certification will be eligible to receive **BOABC Level One (1) Certification.**

CBCO Small: Regular and Associate One (1) members who have received the OBOA CBCO Small Certification will be eligible to receive **BOABC Level Two (2) Certification**.

CBCO Large: Regular and Associate One (1) members who have received the OBOA CBCO Large Certification will be eligible to receive **BOABC Level Three (3) Certification**.

Alberta Safety Codes Council

Residential: Regular and Associate One (1) members who have received the Residential certification will be eligible to receive **BOABC Level One (1) Certification.**

Part 9: Regular and Associate One (1) members who have received the Part 9 Certification will be eligible to receive **BOABC Level Two (2) Certification.**

Part 3: Regular and Associate One (1) members who have received the Part 3 Certification will be eligible to receive **BOABC Level Three (3) Certification.**

SBOA Saskatchewan Building Officials Association

Class 1: Regular and Associate One (1) members who have received the Class 1 certification will be eligible to receive **BOABC Level One (1) Certification.**

Class 2: Regular and Associate One (1) members who have received the Class 2 Certification will be eligible to receive **BOABC Level Two (2) Certification.**

Class 3: Regular and Associate One (1) members who have received the Class 3 Certification will be eligible to receive **BOABC Level Three (3) Certification.**

NSBOA Nova Scotia Building Officials Association

CBO 1: Regular and Associate One (1) members who have received the CBO 1 certification will be eligible to receive **BOABC Level Two (2) Certification.**

CBO 2: Regular and Associate One (1) members who have received the CBO 2 Certification will be eligible to receive BOABC Level Three (3) Certification.MBOA Manitoba Building Officials Association

CBCO Housing: Regular and Associate One (1) members who have received the CBCO Housing certification will be eligible to receive **BOABC Level One (1) Certification**.

CBCO Part 9 Buildings: Regular and Associate One (1) members who have received the CBCO Part 9 Buildings Certification will be eligible to receive **BOABC Level Two (2) Certification**.

CBCO Part 3 Buildings: Regular and Associate One (1) members who have received the CBCO Part 3 Certification will be eligible to receive **BOABC Level Three (3) Certification.**

NBBOA New Brunswick Building Officials Association

NBCBO Level 1: Regular and Associate One (1) members who have received the NBCBO Level 1 certification will be eligible to receive **BOABC Level One (1) Certification.**

NBCBO Level 2: Regular and Associate One (1) members who have received the NBCBO Level 2 Certification will be eligible to receive **BOABC Level Two (2) Certification**.

NBCBO Level 3: Regular and Associate One (1) members who have received the NBCBO Level 3 Certification will be eligible to receive **BOABC Level Three (3) Certification**.

OTHER

Regular and Associate One (1) members who have received certification from Canadian Provinces other than those listed above and who do not hold certification with ACBOA will be reviewed on an individual basis.

PLUMBING OFFICIALS:

Regular and Associate One (1) members who have received certification as a Plumbing Official from other Canadian Provinces will be reviewed on an individual basis.

POLICY OBJECTIVE:

To facilitate the desire of Members to have the opportunity to relocate to British Columbia or the Yukon Territory using their certification obtained in another Canadian Province.

POLICY JUSTIFICATION:

Members, the Association, employers and the public require knowledge of the level of achievement of the holder of the Certificate.
