## **Jim Robison Award**

The Jim Robison award is presented to a member of the association or individual from the building industry for significant contributions to the code development activities and goals of the Association.

Mr. Robison was recognized for his leadership and commitment to the Association and code development. He served the Association with distinction, and he was elected President in 1967-68.
