



NOMINATIONS FOR EXECUTIVE COMMITTEE POSITIONS

In accordance with section 11 of the [Building Officials' Association of B.C. \(Association\) bylaws](#) and Association [Policy 6.3 Elections – Zone Directors](#), the Association is seeking nominees for positions on its Executive Committee (Executive). The nomination process is overseen by the Governance & Nominating Committee. Elections will occur at the 2026 Annual General Meeting (AGM) being held on Thursday, September 24, 2026, from 9:00 AM – 12:00 PM.

Eligible Members

Pursuant to section 3(1) of the Association bylaws, only Regular Members and Associate 1 Members (Eligible Members) may hold elected office on the Executive or nominate an individual to hold office on the Executive.

Nomination Form

All individuals, including incumbent members of the Executive, must be nominated using the prescribed form, which must be submitted to the Association by **3:00 PM on July 15, 2026**, by email at info@boabc.org. The nomination form must be signed by one Eligible Member as the mover of the nomination and the nominee themselves to indicate their acceptance of the nomination.
